WHAT ARE YOU INVESTING IN?

- You are investing in a listed unit trust constituted in Singapore whose investment objective is to achieve medium to long term capital appreciation by investing in the component securities of the STI (which securities are listed on the SGX-ST).
- The STI is maintained by the Index Sponsors³ and represents the performance of the top 30 companies listed on the SGX-ST ranked by market capitalisation.
- Distributions (if any) will be determined at the Managers' absolute discretion

Market and Credit Risks

VALUATIONS AND EXITING FROM THIS INVESTMENT

HOW OFTEN ARE VALUATIONS AVAILABLE?

The Fund will be valued on each Dealing Day. The indicative prices of the Units are quoted on a forward pricing basis and are available from the Managers' website at www.sicim.com.sg. The actual prices quoted will generally be published after the close of business on the Business Day following the relevant Dealing Day in Singapore Dollars. The market prices of Units which are listed on the SGX-ST (which may not be equal to the Value of the Fund) may be obtained from the SGX-ST's website at www.sgx.com.

HOW CAN YOU EXIT FROM THIS INVESTMENT AND WHAT ARE THE RISKS AND COSTS IN DOING SO?

- You can exit the Fund on any Dealing Day by submitting a realisation form to the Managers or through the relevant Distributing Agent through whom you originally purchased Units.
- You will normally receive the realisation proceeds within 6 Business Days from the Dealing Day on which your realisation form is received and accepted.
- Your realisation price is determined as follows:
 - If you submit the realisation form by 3pm Singapore time on a Dealing Day, you will be paid a price based on the Value of the Fund as at the Valuation Point of that Dealing Day.
 - If you submit the realisation form after 3pm Singapore time on a Dealing Day or on a day not being a Dealing Day, you will be paid a price based on the Value of the Fund as at the Valuation Point of the next Dealing Day.
- The net realisation proceeds that you will receive will be the realisation price of the Fund multiplied by the number of Units realised, less any charges. An example is as follows:

Business Day	A day (other than Saturday, Sunday or a gazetted public holiday) on which commercial banks are open for business in Singapore and SGX-ST is open for trading.

Dealing Day	In connection with the issuance, cancellation, valuation and realisation of units, means every Business Day or such Business Day or Business Days at such intervals as the Managers may from time to time determine and reasonable notice of any such determination shall be given by the Managers to all holders at such time and in such manner as the Trustee may approve.
